

WALKING TRAIL EASEMENT NOTE

A PEDESTRIAN WALKING TRAIL/PATH IS CREATED ALONG THE NORTHWEST BOUNDARY OF THIS SUBDIVISION. THE SPECIFIC LOCATION OF THE WALKING TRAIL/PATH WILL BE DEDICATED THROUGH EASEMENTS OF ADEQUATE WIDTH, (TYPICALLY 10 FEET) FOR PEDESTRIAN ACCESS FOR SAID TRAIL/PATH. SAID EASEMENT WILL BE CENTERED ON THE CENTERLINE OF THE TRAIL AS CONSTRUCTED SO THAT IN PRACTICE THE EASEMENT WILL BE TYPICALLY 5 FEET IN WIDTH ON EACH SIDE OF THE CENTERLINE OF THE TRAIL/PATH FOR A TYPICAL TOTAL EASEMENT WIDTH OF 10 FEET. THE EASEMENT AREA IS TO BE KEPT AS PERMANENT OPEN SPACE BUT MAY ALSO INCLUDE LANDSCAPE BUFFERS AND SIGNAGE ASSOCIATED WITH THE WALKING TRAIL/PATH IN ADDITION TO THE TRAIL/PATH ITSELF. THE TRAIL/PATH SHALL BE AS SHOWN ON THE CROSS SECTION OR AN ALTERNATE APPROVED BY THE CITY OF ELIZBAETHTOWN PLANNING & DEVELOPMENT DEPARTMENT AND ENGINEERING DEPARTMENT. IT SHALL BE THE RESPONSIBILITY OF THE SUBDIVISION DEVELOPER TO CONSTRUCT THE ENTIRE WALKING TRAIL/PATH THROUGHOUT THE DEVELOPMENT. THE DEVELOPER AND INDIVIDUAL LOT OWNERS SHALL BE HELD HARMLESS OF ANY LIABILITY RELATING TO ANY ACCIDENT THAT MAY OCCUR ON SAID WALKING TRAIL/PATH.

IN ADDITION TO THE PERIMETER TRAIL/PATH, CONNECTIONS (WITH EASEMENTS) FOR PEDESTRIAN ACCESS TO/FROM THE PUBLIC SIDEWALKS ALONG THE STREETS IN THIS SUBDIMISION SHALL BE CREATED. THESE CONNECTIONS WILL BE LOCATED ALONG VARIOUS LOT LINES TO ALLOW FOR A CONTINUOUS PEDESTRIAN SYSTEM IN THE DEVELOPMENT.

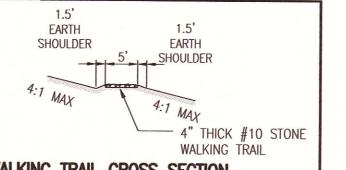

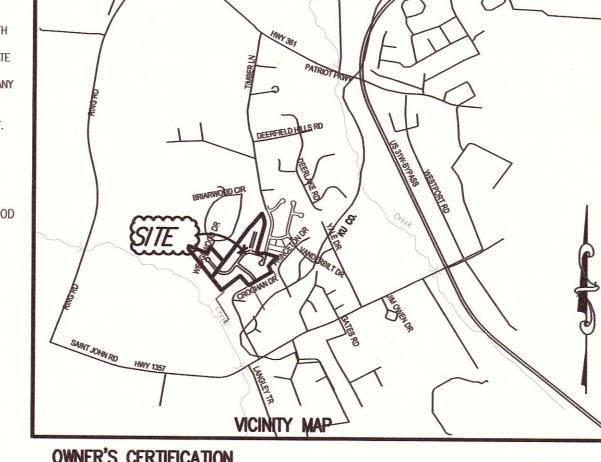
# OPEN SPACE / NON BUILDABLE LOTS 110 & 124

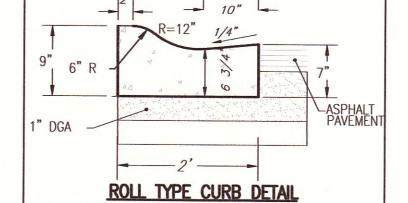
